# Supportive Documentation for the VA CLE Course

"Veterans Law & Claims Procedures for Maintaining VA Accreditation"

## A. Description of the Course

- A **Claims Support Flash Drive** with over 240 claim forms, support forms, reports, questionnaires and adjudication instructions for completing several types of disability claims (about 30).
- A Certificate of Completion received only upon participant submission of all correct multiple
  training code numbers embedded in the flash drive and online presentation. This is to verify
  the participant has viewed the presentation in its entirety.

## B. Description of the Method of Presentation

- 1. This training is designed as a college-course lecture which is used as an introduction to the textbook
- 2. The textbook the engine driving this college level course is the most complete and upto-date instruction manual/handbook currently available for all types of veterans disability claims and is based on the new fully developed claim process from VA
- 3. The lecture is specifically designed to promote a learning experience and is not a video of a training conference with talking heads speaking extemporaneously
- a. The lecture is based on a carefully scripted, interactive audiovisual presentation
- b. The lecture is rich in information and visual support
- c. The lecture references specific portions of the 506-page textbook provided with the course
- d. The lecture instructs on the specific use of the accompanying flash drive disk with over 240 forms and documents
- 4. The lecture introduces through 3.02 hours of audiovisual presentation, over 300 carefully scripted learning concepts referring to the following areas of veterans benefits as found in the textbook/handbook and other supplementary information furnished with the course
  - applicable federal code
  - applicable federal rules
  - definitions
  - general adjudication procedures

- qualification requirements
- application instructions for over 30 different types of disability claims
- · use of checklists
- use of reports, pertinent forms, opinion letters and other important documentation
- VA requirements for representation of veterans requirements for CLE
- Seven case studies demonstrating how various applications for various veterans benefits are developed and submitted for successful claims

### C. Method of Evaluation and Tracking

- 1. Input from the course is encouraged
- 2. Online evaluation form available for participants to submit feedback
- 3. The faculty is available via email or phone for any questions or follow-up instruction
- 4. A course certificate of completion is provided under the following conditions a. course participant certifies with a signature the completion of the course
- a. For evidence of completion for VA Office of General Counsel the participant provides a course training code that is embedded in the training and can only be obtained by watching the lecture
- b. For purposes of state bar credit for this course where it applies, and additional 4 training codes are embedded in the presentation to encourage participants watching the entire course. The code segments are so short, it would be very difficult to go through the training frame by frame to find those codes and it would take the same amount of time to just simply watch the training.

### D. Qualifications of the Faculty Presenting the Course

**Thomas Day:** Thomas Day is a Veteran of the Vietnam War. He has had over twenty years of experience teaching professional seminars and working in the field of long-term care. He is an Accredited Agent with the Department of Veterans Affairs (part of a select group of about 500 across the country) and has helped numerous veterans with their benefits. He assists accredited attorneys and claims agents daily with questions they have about Veterans Law and the application and appeal processes. He has authored four books covering over 1,200 pages of federal code and federal regulations pertaining to veterans. Tom is the director of the National Care Planning Council and is a board member and Chief Training Officer for the Senior Veterans Service Alliance.

**Jed Winegar:** Jed is an Accredited Claims Agent with the U.S. Department of Veterans Affairs.
